**CALL FOR PAPERS**

The Organizing Committee of the 53<sup>rd</sup> International Congress of Americanists (ICA) extends a warm greeting to the national and international academic community working in the field of studies of the American Continent. Whether the research is carried out from the perspective of a single discipline, or using a multi-disciplinary approach, the Organizing Committee invites you to participate at the 53<sup>rd</sup> ICA, to be held at the prestigious Historical Centre (Centro Histórico) in Mexico City from July 19<sup>th</sup> to July 24<sup>th</sup> 2009.


The International Congress of Americanists holds the longest interdisciplinary tradition of studies on this subject. It has been convened uninterruptedly since 1875 (when the first one was held in Nancy, France). Since 1895, it is held every three years, the host city changing from country to country—and also between continents—so that an edition in Europe is followed by an edition in America, and vice versa. In the last two decades, congresses were conducted in the Netherlands (Amsterdam 1988), United States (New Orleans 1991), Sweden (Stockholm-Uppsala 1994), Ecuador (Quito 1997), Poland (Warsaw 2000), Chile (Santiago 2004), and Spain (Seville 2006.)

The chosen theme for the 53<sup>rd</sup> ICA will analyze the development of the different cultural, social, and political traditions, as well as technological innovations in our continent, pertaining to the peoples of Amerindian origin. It will also examine the European, African, and Asian contributions to this field of studies. Our focus is to allow for a dynamic approach that includes the mestizaje processes and social and political conflicts, along with those transformations that stem from the current globalization phenomenon. The theme encompasses, as well, the construction of our own identities within a plural and multicultural context. It incorporates topics related to the development of archeological and historical research, anthropology, ethnohistory, linguistics, literature, cultural heritage, museography, human rights, research on urban and rural movements, economical studies, philosophy, sociology, law and political science, and education.

The Organizing Committee of the 53<sup>rd</sup> ICA wishes to express its gratitude for the trust granted to it by the Liaison Subcommittee, designated at the general assembly of the 52<sup>nd</sup> International Congress of Americanists. It is worth noticing that it was precisely in Mexico (1895) where the first Congress outside the European continent was ever held. We have been honored to host other editions as well in 1910, 1939, 1962, and 1974. In undertaking the challenge and privilege of organizing the sixth edition to be held in Mexico, we can only say that our goal is to attain the high standards of previous congresses, and, at the same time, promote new activities to strengthen scientific institutions; researchers' networks and programs of study on Americanist studies.

Our intention is to revive the tradition of publishing the Proceedings of the Conference by means of a formal, electronic edition. The Congress will be held in the renowned Historical Centre (Centro Histórico), located in Mexico City's downtown. The National School of Anthropology and History (ENAH) is the institution that hosts this prestigious event, and the Organizing Committee has deemed it pertinent to house the Congress in the ancestral Historical Centre, among the *Templo Mayor de Tenochtitlán*, the famous monuments of the Colonial Period, and the traditional spaces of the development of the Mestizo world.

Besides its symbolic meaning, the Historical Centre in downtown Mexico City has all the conveniences of modernity, with an array of options that cater to every need, appropriate means of transportation, and



enough variety of housing options for all budgets. This will facilitate the participation of students and young graduates. The Historical Centre is also conveniently located near Mexico City's International Airport, and is known for its variety of restaurants which offer a vast array of local and international cuisines. This will provide an opportunity for our guests to taste the best in ethnic and regional cuisine or choose their preferred food. Guests will also enjoy proximity to important libraries, as well as famous museums nearby, which we hope will enrich the experiences of all participants..


Certainly, neither archeology nor history are at odds with the conveniences of modernity. Therefore, the Congress will enjoy adequate conference rooms, equipped with the latest technology, all within close proximity, providing efficient functionality .

### **Theme Areas**

We wish to continue to achieve a balance between the theme and scope of this congress, and the need to guarantee the open participation of the highest possible number of scholars studying the different fields of knowledge of the American reality. Hence, the 53<sup>rd</sup> ICA has decided to maintain its classical themes to share and discuss relevant scientific developments, and at the same time make space for new themes. An emphasis on inter and multi-disciplinary approaches to understanding the global processes at work in the American continent is a key goal of this Congress. The themes will be as follows:

We invite all our colleagues who are interested in proposing symposia, to do so taking into consideration the above-mentioned general topics. Papers and proposals should be submitted according to the instructions stated below. A scientific committee for each theme will evaluate each symposium proposal and all papers submitted, and dictaminate on its approval .



## **Forms of Participation**

The Organizing Committee of the 53<sup>rd</sup> ICA will open new avenues of presenting topics in order to provide efficient mechanisms for the simultaneous exposition of all works within the week of the Congress. It will endeavor to promote the fields of research, teaching, and the formation of new generations of specialists in Americanist studies.

To keep up with the contemporary trends that allow for plural participation and open new avenues of communication, the Organizing Committee has decided to accept innovations, such as Poster Sessions. These will be evaluated by a special committee, which will award prizes and honorable mentions as a way to motivate young scholars and students who often prefer a more flexible approach over reading papers. It is important to note that both, poster sessions and formal papers, will have to first be accepted in a symposium in order to be displayed and/or read.

Hence, forms of participation will be the following:

- Symposia
- Poster Sessions
- Parallel Events

### **Symposia**

1. Symposia must have a maximum of two convenors, preferably from different countries. They must submit an electronic address and telephone and fax numbers.
2. It is not possible for a convenor to coordinate more than one symposium during the Congress.
3. Convenors will:
  - Establish the technical regulations for papers to be read and keep the discussion within the chosen theme.
  - Approve or reject proposed papers.
  - Abide by the symposium's program and schedule and decide about the publication of the Proceedings regarding those papers presented in their specific symposium.
  - Eventually, find a sponsor for these.
4. Regarding all symposia presented, the Organizing Committee of the 53<sup>rd</sup> ICA will publicize the pertinent information before and during the Congress. They will provide an appropriate location with adequate multimedia aids to hold the symposium.
5. Each symposium must have at least eight and no more than twenty papers. The time allotted to each symposium will consist of ten hours.
6. Because of the nature of the Congress, participants must be advised that simultaneous translation will not be available
7. Symposium proposals shall be submitted before March 31<sup>st</sup>, 2008. No proposals will be accepted after this deadline. Proposals must be sent to the following electronic addresses:

All symposia proposals must include the following information: Full name and address of the convenors, title of the symposium, a summary consisting of 300 words, and containing a preliminary list of each participant as well as the title and summary/abstract of each. Abstracts must have a maximum of 200 words and should include five key-words. This requisite applies to each paper to be read at a given symposium. Initial acceptance shall be decided by the respective scientific committee, which will communicate its decision on or before the 31<sup>st</sup> of May 2008.

For a symposium to be finally accepted and included in the Congress Programme, it must have at least eight registered papers. All speakers must have paid the Congress Registration Fee before December 31<sup>st</sup> 2008. Please note that if by this date these requisites have not been fully met, the symposium will not be included in the official Programme.

### **Symposium Papers**

Proposals for papers must be submitted directly to the symposium convenors for their approval to be included in the symposium and the Congress Programme. Participants can present a maximum of two papers in different symposia. The registration deadline for presenting papers is December 31<sup>st</sup> 2008. Should any symposium convenor accept new papers on a later date, the organizers cannot guarantee their inclusion in the official Programme of the Congress.

### **Poster Sessions**

1. This is an innovative avenue of presenting research at the ICA. Its goal is to facilitate the participation of investigators and to provide more fluid ways of communicating relevant data. Poster Sessions enhance interaction among participants. It also allows researchers to tackle topics that may usually not be dealt with in symposia. Poster Sessions, however, will have to remain within the general themes of the event.
2. A scientific committee shall be designated for each Poster Session exhibit.
3. The deadline to submit proposals for Poster Sessions is September 30<sup>th</sup> 2008. Proposals must be sent to the following electronic address:

4. Presenters must submit a summary of the Poster Session containing no more than 100 words, along with five key-words. Notification of acceptance will be delivered electronically before November 30<sup>th</sup> 2008.
5. All registration fees must be covered by December 31<sup>st</sup> 2008. Should it be otherwise, the Poster Session will not be included in the official Programme.
6. Texts of Poster Sessions will be included in the Proceedings/Memoirs of the Congress, which are to be published. Posters must adjust to the following measures: One metre wide and 1.30 meters in height. All didactical materials have to be provided by the presenters.

### **Audiovisual Section**

This is a new section at the ICA. Its goal is to facilitate the participation and exposition of researchers who prefer this form of presentation. The deadline for paying all registration fees for audiovisual presentations is September 30<sup>th</sup>, 2008. Presenters must send a summary of no more than 100 words and five key-words before the deadline to the following electronic addresses:

Notifications regarding acceptance will be sent before December 31<sup>st</sup>, 2008. Proposals submitted after this date may not be included in the official Programme of the Congress. Submitted texts are to be included in the Proceedings of the 53<sup>rd</sup> ICA.

### **Seminary for Directors of Research Centers and Heads of Research Projects**

This space has been created in order to freely share experiences and tackle conceptual and strategic problems related to diverse fields of study. Another goal is to get to better know the different institutional research policies represented in the Congress, and promote inter-institutional cooperation in areas such as student and professors exchange programs, exchange of specialized publications, promoting joint editions for future works, exploring possibilities for research fellowships, and establishing formal cooperation agreements.

All registered research centers have the right to present a Poster Session to describe its mission. They will be included in a special publication issued as a compendium, whose aim is to acquaint all participating institutions with each other. It is recommended that interested parties include a directory of investigators along with current research projects and electronic addresses.

### **Seminary for Directors and Professors in Charge of Graduate and Post-Graduate Programmes**

This space has been created in order to freely share experiences and tackle conceptual and strategic problems related to different fields of study. Another goal is to get to better know the different institutional research policies represented in the Congress and promote inter-institutional cooperation in



areas such as student and professor exchanges, exchange of specialized publications, promoting joint editions for future works, exploring possibilities for research fellowships, and establishing formal cooperation agreements.

All registered schools, faculties, departments, and study programmes have the right to present a Poster Session to describe its mission. It is recommended that interested parties include a directory of professors and investigators along with current research projects and electronic addresses. It is also desirable to include a summary stating the type of libraries, laboratories and institutional infrastructure available in their educational centers, as well as contact information and admission requirements.

### **Exhibits and Stands of Graduate and Bachelor Programmes Related to Themes of the Congress**

The goal of this activity is to reach a wider audience; the attendant public at large. There will be an appropriate space for exhibits and interaction with potential students.

### **Research Projects Exhibit**

The organizers have provided a space to showcase exhibits of different graduate, post-graduate and research programmes from attendant institutions. Although posters will be a major means of reaching the attendees, we also encourage the distribution of pamphlets and any other means deemed pertinent by attendant institutions.

### **Special Meetings of Academic Societies and Researchers' Networks**

Habitually, academic societies welcome the confluence of a significant number of specialists. This can be an ideal time to schedule their annual meetings and such. The Congress will take into consideration all proposals and will facilitate the appropriate space for such events. Requests must be sent before January 31<sup>st</sup> 2009. Meetings of researchers networks also will be considered by the Congress according to available means. The Congress will take into consideration all proposals and will facilitate the appropriate space. Requests must be sent before January 31<sup>st</sup> 2009. In this case, proposals shall be submitted in writing by at least five researchers registered for the Congress.

### **Publication of the Proceedings of the Congress**

The Congress will publish the Proceedings in digital format with an ISBN. This includes all plenary sessions and symposia with all papers presented. Authors must send the Organizing Committee a signed authorization that will be later requested. Presenters who wish to be included in the publication of the Proceedings must have covered all registration fees. We will send additional information as far as required format and publishing specifications. The magnitude of this kind of international congresses and the printing costs, have led to more dynamic and efficient ways of making materials accessible to the public; digital CD's, according to our experience, are a most feasible alternative. The Deadline for papers and other materials to be published in the electronic Proceedings is February 28<sup>th</sup>,2009. All works will be digitally secured to avoid their reproduction while still allowing for printing.

Another advantage of electronic formats, beyond their great capacity to store data, is the possibility of including tables, charts and graphics with great generosity. The CD edition of the Proceedings does not preclude or compete with proposals to publish printed monographic editions or book compilations, as is usually the case in many congresses. Symposia convenors can request, in agreement with their respective presenters, not to be included in the digital Proceedings, if deemed necessary.

### **Book Fairs (New and Used)**

The Congress will open its doors to publishing houses, journals, and specialized bookstores to sell their materials in exhibits and stands. This invitation will include bookstores that carry a stock of out-of-print and used materials in order to better serve the needs of all participants.



### **Exhibits of Publications by Congress Participants**

Participants are welcome to bring all of their relevant publications. A space will be available for this purpose within the scope of the symposia. The National School of Anthropology and History will create a research and educational fund with donations received by attendees.

### **Participant Categories and Registration Fees**

All participants, including symposia coordinators, speakers, registered participants and students, are entitled to the following:

1. To participate in all the academic and social activities of the Congress.
2. To propose motions, speak and vote at the General Assembly.
3. To receive all the information material and any other service that may be provided to participants.
4. There will be a special discounted student registration fee and a sponsorship system. Detailed information will be available in the near future


### **Institutional Registration**


### Structure and General Programme

- Round Tables: Meetings of International Committees as Societies and the like


### Certifications
